## MSU Recycling Q and A

**Q:** Plastic bags: Is it OK to put big, thick plastic bags in the plastic bag bin? I'm talking about the bags that a 40 pound load of water softener salt would come in. Most of what I see in that bin is the thin bags that you get at the grocery store or discount store.

**A:** We only accept clear or translucent plastic bags for recycling. Thicker bags like salt bags or cat litter bags are not accepted.

Q: Plastic things with small metal parts inside: When I get ready to recycle the plastic container for window cleaner, body lotion, or similar products, there is usually a spray or dispenser mechanism that is mainly plastic but has a metal spring inside. And the mechanism usually looks like it has more than one kind of plastic. Should I throw these mechanisms away or put them in with my mixed plastic recycling?

**A.** As for plastic with small metal parts inside, because it is more than one material, it can't be recycled (unless you were to separate each part).

**Q:** Plastic bottle caps: It looks like the caps on my plastic bottles are always made of a different kind of plastic that what was used to make the bottle. Would it help you if I removed these caps before recycling the bottles? I have been removing them but also putting them into the recycle bin; should I just remove them and discard them?

**A:** We can accept the bottle caps as well—no need to remove them! You can continue to recycle them in the Mixed Plastics 1-7.



### Gordon Guyer, former president of MSU, dies at 89

Dr. Gordon Guyer, the 18th president of MSU, died at age 89 on March 30. Guyer earned all three of his degrees at MSU, and joined the faculty in 1953. He was president in 1992-93, and led the academic calendar change from quarters to semesters. Guyer authored more than 70 papers on aquatic ecology, insect control technology, integrated pest control, public policy and international agriculture. While serving as president, he named Lou Anna K. Simon as interim provost and appointed Tom Izzo as men's basketball coach. Commenting on his life's work, Simon said that he was known and respected in every corner of the state.

#### **Straight to the Point**

Market Update - After a horrendous start to the year, markets managed to rally from mid-February through late April. Domestic stocks came within a few percent of their all time highs, set last May. More recently markets have been choppy, as they've neared upper bound resistance and some of the same global growth concerns we saw earlier in the year have resurfaced. This is not surprising, as we've expected markets to remain volatile, even as they potentially move higher. With summer on the horizon, we enter a period of lower trading volumes and seasonal weakness in stocks. In addition, the pending elections are likely only going to fuel market volatility in the coming months.

**Investment Implications** - Through the ups and downs we've seen thus far in 2016 there has been a reversal in underlying market leadership. As we've expected, energy and industrial stocks have been among the better performers. Meanwhile, recent market darlings in the technology and healthcare sectors have been among the laggards. In the short-term we continue to favor the better "value" plays in the market, while also advocating for alternative strategies that can diversify portfolios and/or mitigate any market volatility.
